The Reno-Tahoe Airport Authority (RTAA) Purchasing and Materials Management Division is currently accepting sealed bids for the Roof Replacement Project Mini Warehouse Storage Building C&D at the Reno-Tahoe International Airport, **Invitation to Bid Number 17/18-09**. All bids must be received and time stamped by the RTAA Purchasing and Materials Management Division, 2770 Vassar Street, Reno, Nevada not later than **2:00 p.m., local time, March 1, 2018**.
2. Sealed bids shall be opened by the RTAA Purchasing and Materials Management Division at **2:00 p.m., local time, March 1, 2018**.
3. A mandatory pre-bid conference and site inspection for all bidders intending to submit a bid will be conducted **January 17, 2018 at 2:00 p.m.** commencing in the RTAA Purchasing and Materials Management Offices, 2770 Vassar Street, Reno, Nevada.
4. Award of contract may be made by the Board of Trustees at their regularly scheduled meeting in April 2018.
5. To assure consideration, all bid responses shall be enclosed and sealed in an envelope that is addressed to the Reno-Tahoe Airport Authority, Purchasing and Materials Management Division, 2770 Vassar Street, Reno, Nevada 89502, and endorsed with the bidder's name and address, marked with the name of the bid, the date and time to be opened, and ITB 17/18-09.
6. Bids received after time set for receipt will be rejected.
